Dr. Bill Fielding addressed the issue concerning **graduate** tuition for traditional and hybrid classes. After much discussion, it was recommended that all hybrid classes (defined as 51% - 99% courses taught on-line) at the graduate level will be charged the same rate as on-line courses at the rate of \$439.per hour for all in-state and out-of-state students. After a unanimous vote in favor of the recommendation, **the proposal will be submitted to the president for his approval.**
