CRIMINAL LAW LIBRARY RESEARCH GUIDE

(CJ301, CJ500, SW320, 322)

INTRODUCTION

Criminal Law refers to a body of rules and statues that defines conduct prohibited by the government because it threatens and harms public safety and welfare and that establishes punishment to be imposed for the commission of such acts. It consists of the criminal laws themselves and the law of criminal procedure. Each state and federal government has its own set of criminal laws. Criminal law (CJ 301) provides analysis of the origin and sources of criminal law as well as definition of parties to crimes and affirmative defenses. It also provides discussion of specific crimes of common law and in state and national statues. Seminar in Contemporary Criminal Justice Issues (CJ 500) provides an overview of the criminal justice system and its various sub systems. Most related print sources (such as books, periodicals) are located on 4th floor and 10th floor in Houston Cole Library (HCL), electronic sources (such as databases) can be accessed via computer stations on each floor.

PRINT SOURCES

Books and print journals are the main pint sources in the HCL providing a foundation for research. Books and journal articles may also contain useful bibliographies which may lead to additional sources of research.

When looking for print materials, consult the Library of Congress Subject Headings to select the proper term(s) to use as subjects under "Library Catalog". Some possible subject headings can be: Crime, Criminal investigation, Criminal courts, criminal behavior, Criminal Justice, and etc. "Keyword Anywhere" & "Title" searches can also be conducted under the "Library Catalog" (<u>http://library.jsu.edu/</u>).
