- 3. The list of officers and directors is included in this newsletter. My thanks for their work and support this year. Special thanks to Therman Greene for his continuing, dedicated work for the scholarships and to Cliff Lanham, our Past President for two years, for his invaluable advice. Please contact any one of us about your questions or concerns.
- 4. We're looking for more grads from the '80s and '90s to step up and play key roles in the future for the ROTC Alumni Chapter. With all respect to them, the older gang of the '50s and '60s knows it's time for them to move on! We need to keep the Chapter viable so that support of the ROTC program continues. Can you play a role? Will you step forward now? If you would like to be an officer or director of the chapter, contact me.
- 5. Year Group Coordinators were first appointed in 2003 for the years 1951-2002. Coordinators are to contact members and maintain mailing and email lists of the Year Group members; attempt to locate "missing" alumni from their year; and encourage their year group to attend the annual banquet and share a table. I encourage your efforts as Coordinators. Let me know if you need a list of ROTC graduates for your Year Group.
- 6. While the 'named' scholarships continue to do well, last year the Chapter established the ROTC

Scholarship Endowment to provide scholarships to ROTC students for the long term. \$25,000 is needed within three years to establish a base endowment and we remain significantly short of that goal. The second phase will be to build the Endowment to more than \$100,000 for it to be a viable fund using only the earnings for scholarships. Please help us spread the word about the Endowment.

#### **Professor of Military Science Update**

JSU ROTC has continued to uphold its high standards and exceptional performance this year. As the PMS, I could not be more proud of this battalion. Maintaining its excellence, JSU ROTC's cadet rankings are once again above Cadet Command's average, and we commissioned eighteen highly qualified Lieutenants into the United States Army this year. Currently, we have 86 cadets enrolled in the program and 36 of those are contracted. Of course, recruiting is ongoing and we already have several recruits returning from Basic and AIT who will be joining us for the Spring semester.

The number of cadets we send to training and specialty schools is ever increasing. This past summer, we sent fourteen cadets to LDAC (Leader Development and Assessment Course) at Fort Lewis, Washington, where five of our cadets achieved an 'E' (Excellent) evaluation, which

is more than most ROTC programs can boast. We also sent 5 cadets to LTC (Leader's Training Course) at Fort Knox, KY where they received a crash course to prepare them for life as an Army officer. A total of 1810 cadets attended LTC from across the country, a record breaking number for this past decade. More impressive, two of our five attendees will be going into the Army Nursing field. For specialty schools, we sent 2 cadets (CDT Antione Williams and CDT Bobby Hill) to the US Army Basic Airborne Course. These slots are highly competitive to obtain and we commend these cadets for completing the rigorous training selection program to acquire them.

#### **Professor of Military Science Update (con't.)**

We have two new additions to JSU ROTC this year. The first is the Study Hall Program which was implemented last year by our 2008-2009 MS-IVs. This program was developed for cadets to increase their GPAs and further overall academic success, especially for the cadets' accessions packets. So far, it has been a success! We hope to have 100% of our cadets above a 3.3 GPA by 2010. The second and most noticeable addition is the establishment of the battalion Military Library. It enables cadets to access volumes of military history reference material. Any alumni donations of military history books or reference materials are welcome.

In addition to the four feeder JROTC programs we already had established, (Anniston High School, Talladega High School, Etowah High School and Gadsden City High School) Albertville High School will make our fifth JROTC feeder school. We have reactivated Gadsden State Community College as our feeder community college as well. This will broaden our scope and facilitate the recruitment of more exceptional officers. Along with the additional feeder schools, we have expanded our cadre to include the new Senior Military Instructor, MSG Jerry Laitinen, the new Operations NCO, SFC Kenneth Mercer, and returning to our cadre is the new Operations Officer, CPT Paul Painter.

Looking to the new year, I am proud to introduce to you our new cadet commander, CDT LTC Bobby Hill. CDT LTC Mike W. Schreckenbach relinquished command of the Gamecock Battalion to CDT LTC Bobby Hill during the Change of Command Ceremony, which took place on 3 September 2009 on the lawn of Bibb Graves.

I want to thank all of the alumni of this program for your dedication and support of this battalion. Without you, we would not have the foundation that we do, nor the high standards to maintain. Our cadets are more than grateful for your generous contributions to the Alumni and Memorial Scholaships. To show our appreciation and keep you involved in the program, we welcome each and every one of you to our upcoming events.

#### **ROTC Scholarship Endowment Established!!**

In a bold and strategic move, the JSU ROTC Alumni Chapter in January 2009 mapped out a long-term scholarship program on behalf of the ROTC Department. The scholarship committee of the ROTC Alumni Chapter has found that more and more ROTC graduates are looking for ways to contribute to the ROTC Department because of the wonderful experiences they had while at JSU. Fortunately, we have a number of dedicated individuals and organizations to continue the annual program in the short term to provide scholarships. Coupled with the generous support of the university that has been matching these annual donations, the Chapter will be able to support 10 to 15 cadets with small scholarships for the next three years. In January 2009, the Chapter established the formation of the ROTC Scholarship Endowment in concert with the University. To ensure a viable scholarship program, the Endowment must accumulate \$25,000 within three years. As of now the Endowment has about \$7000 and some \$3000 pledged toward the fund. Considering the nation's economic condition, the Chapter is very pleased with the results so far! It is the goal of the Chapter to start using this fund in the year 2015 for cadets that need assistance while attending JSU. Looking in the wish mirror, JSU has commissioned some 1500 Cadets since 1950. If each graduate of the ROTC program donated just \$100, this Endowment could have a nice balance of \$150,000 plus in short order! Where is that dream mirror? The ROTC Alumni Chapter is seeking any and all graduates that would like to participate in the Endowment or the present annual matching scholarship program.
